AACAMH/ARGEC WORKFORCE DEVELOPMENT CONFERENCE - Older Adults and Substance Use

- Purpose: Raise the workforce's awareness about older adults and substance use.
- Focus: Alcohol and prescription drug use/misuse
- Proposed Title: Building Workforce Competency: Substance Use and Misuse by Older Adults
- Presenters
 - Fred Blow, Ph.D., a nationally recognized expert on the subject from the University of Michigan has agreed to be the Keynote Speaker and is working with us on the content of his presentation.
 - Stephen H. O'Neil, MA. Project Director, Georgia BASICS, from the Department of Behavioral Health and Development Disabilities (DBHDD) has agreed to present on SBIRT (Screening, Brief Intervention and Referral to Treatment). SBIRT is an evidence-based practice model which is proven to be successful in modifying the consumption/use patterns of at-risk substance users and in identifying individuals who need more extensive, specialized treatment. SBIRT is a comprehensive, integrated, public health approach that provides opportunities for early intervention before more severe consequences occur.
 - Nzinga Harrison M.D. has agreed to present on the science of addiction and the medical issues and potential complications of substance use for the older adult population as well as address comorbidity.
 - Local providers who have a substance use program component that is directed at the older adult population as well as the Hanley Center will be invited to participate in a panel presentation that covers services they offer for older adults, how to access the services; the name and phone number of the program contact for admission or questions in general re: older adult services; and what insurance they accept. The providers will also be asked to be a conference sponsor to help with expenses (speaker fees, meals) and will be offered a table if they want to put out materials about their older adult substance use services.
 - A suggestion was made to have a handout that lists the above information for each of the providers

- Suggested programs that are believed to have an older adult substance related component include Ridgeview (they have recently developed a new older adult program), Anchor, and Tenet, - need to check with Peachford and Talbott – plus the Hanley Center who has expressed an interest in participating and supporting the conference
