Follow-Ups

- Jocelyn provided an update on a recent meeting with the marketing and clinical director from the Hanley Center of Palm Beach, Florida about their Geriatric Substance Abuse Program. They will be establishing a Resource Center in Atlanta offering AA and NA groups as well as access to their Florida treatment program. They are looking at various Atlanta resources for aftercare and follow-up once a person completes inpatient treatment. They are open to providing whatever support they can to our workforce development conference.
- Cathy spoke to sociologist Dr. Mariam Boeri, an Associate Professor at Kennesaw who has
 done research on older adults and substance abuse. She too is willing to participate in the
 conference. Dr Boeri's work and research was introduced to us by Molly Perkins at our
 December meeting. Several of her publications were shared with Coalition members by email.
- As mentioned in the last meeting, the purpose of the conference is to raise the workforce's awareness about older adults and substance use. According to SAMSHA's Older Americans Issue Brief 2, Alcohol Misuse and Abuse Prevention (distributed with the December 2012 minutes):

"The misuse and abuse of alcohol in older adults present unique challenges for recognizing the problem and determining the most appropriate treatment interventions. Alcohol use problems in this age group often go unrecognized and, if they are recognized, are generally undertreated"

Focus probably limited to alcohol and possibly prescription drug abuse – Catherine Ivy plans to touch base with an FBI contact she knows.

Potential conference topics include:

- Increase awareness about the issue (Linda Paderson of the CDC suggested as a potential presenter Jessica Gill will make contact with her)
- Impact on clinical and community providers
- Assessment Tools (SBIRT)
- Resources Including support group like AA, NA, al anon
- Interventionist
- Medical impact and issues science of addiction and older adults medication management anxiety disorders leading to substance abuse (Cathy will see if Dr. Nzinga Harrison who has expertise in this area might be a potential presenter)
